Please be advised that I am hereby giving my two week notice that I am quitting a hostile work environment.

I have been employed since March of 2019. I have done everything I can with excellence to bring up the occupancy of Barcelona Lofts to the highest standard possible. While I do appreciate the opportunity I can no longer stand by and watch the illegal and unethical practices of Valencia Lofts, Nancy Bustamante Schroeder spill over onto innocent people.

Mr. Milmo I have warned you on numerous occasions about the following:

- 1) Nancy's lies regarding being "100 % full" when in fact she had told me the evening before that she had 10 empty units.
- 2) Nancy keeping our residents packages and then months later showing up with the new IPHONE our resident reported stolen as he went to claim it from Valencia management office only to be told they did not have it- (an ongoing investigation will prove this out)
- 3) Your constant disrespect to myself and Michelle Menor who has served you faithfully and brought your business to the level it is today. You have constantly tried to belittle her and humiliate her- enough- YOU ARE THE PROBLEM!
- 4) You were told on January 13, 2020 that the rumors of your alleged affair with Nancy Bustamante Schroeder are coming from her telling EVERYONE "she is sucking the chrome off your bumper" –
- 5) You have not listened.
