Center for Disease Control and Prevention. Legal Authorities for Isolation and Quarantine

Entry Requirements: The US Center for Disease Control (CDC)

It was noticed that your dog is not up to date on all the shots required for travel, most especially at this time of the pandemic.

- 1) Your puppy does not have a Rabies vaccine.
 - 2) She is not up to age for a Rabies vaccine.

Therefore, she will be quarantined.

Quarantine Information:

Dogs not accompanied by proof of rabies vaccination, including those that are too young to be vaccinated (i.e. less than three months of age), may be admitted if the importer completes a confinement agreement and confines the animal until it is considered adequately vaccinated against rabies (the vaccination is not considered effective until 30 days after the date of vaccination). Puppies that are too young to be vaccinated must be kept in confinement until they are old enough to be vaccinated, and then confined for at least 30 days after the vaccination. Dogs without vaccines must be vaccinated within four days of arrival at their final destination and within ten days of entry into any States and must be kept in confinement for at least 32 days after the date of the vaccination. Dogs may not be sold or transferred to other owners during this period of the confinement, and the person that signs the confinement agreement is responsible for

ensuring the conditions of the agreement are met. Importers must provide a contact address where the dog will be kept during the confinement period. If the importer will be housing the dog at several addresses or traveling with the animal, all points of contact must be provided.

--- The puppy mentioned above Was registered on today's flight to Minnesota. Later a Credential Veterinarian noticed that the puppy had a high increase in body temperature and couldn't be put on the last flight to Minneapolis–Saint Paul International Airport, from From New Mexico because the dog has been so stressed out and lacks the required rabies

vaccines as the dog is underage for the vaccine.

*No Rabies Vaccination (Probably because the dog is bellow 15 weeks old.) - The pet mentioned above are required to go through a rabies program after 31 days of vaccination.

*No Canine Certificate - Being shipped as a pet cargo, The above-mentioned dog is required to have come with a Canine Certificate sign by a State Registered Vet in sending location.

 st insurance cover $\,$ (Paid)- $\,$ no puppy should be shipped within the USA $\,$ without being covered by an insurance policy.

The pet mentioned above will be required to go a Quarantine period of 32 days and feeding and accommodation for the above-mentioned puppy will be under the importer's expense coupled with any extra shots and medical checkup by a registered Vet. The Importer is required to pay \$32 daily for 32 days during the pet confinement in our Quarantine facility. Any extra health checkup or in-case illness that befalls the puppies in question will be checked by our vet on the Importers expenses.

How to uplift Quarantine on your pets.

Uplifting the Quarantine on the puppy mentioned above is quite easy if Legal procedures are being followed.

-We shall charge the Exporter for penalties. The reason being that the puppy was shipped without the necessary paperwork, The CDC and APHIS will be charging the Exporter a Refundable amount of \$550

-The Exporter of the puppy mentioned above will also be charged a Refundable Amount of \$550 for shipping the puppy within a period of 15 weeks with no Rabies shot records. Making it a total of \$550 Refundable amount.

-A replica of this email will be sent to the Exporter.

The Importer will be charged on a 100% Refundable Amount of \$2,500 These charges will be used to uplift the Quarantine impose on the puppy mentioned above and proper vaccination will be administered by a State registered Vet to resume the delivery procedure.

- The Sum of \$2,500 will be refunded upon the delivery of the dog at your location by a refund agent from South Pacific Logistic. & USDA. The sum of \$2,500 will be added to your previous Reimbursement Funds. and will be jointly refunded upon delivery at your location.

Do get back to us with info, Whether you will be following the Quarantine Procedure OR You will request to uplift the Quarantine impose on your pet.
