CRATES REQUIREMENTS
TO TRANSPORT YOUR PET AS CHECKED BAGGAGE OR CARGO, YOU MUST USE AN
APPROVED SHIPPING CRATE AND IT MUST SHIP IN ACCORDANCE WITH THE A.S.
DEPARTMENT OF AGRICULTURE (ADA) GUIDELINES. THE CRATE MUST PROVIDE
ENOUGH ROOM FOR YOUR PET TO STAND AND SIT ERECT -- WITHOUT THE HEAD
TOUCHING THE TOP OF THE CONTAINER -- AND TO TURN AROUND AND LIE DOWN IN
A NATURAL POSITION.

Dear client,

This is to notify you that we're in possession of your puppy registered for delivery. Your puppy has been checked and confirms healthy for delivery.

As per ADA guidelines on pet shipment, it is an absolute requirement that the puppy checks and examines for at least three (3) hours prior to the time of delivery, we have carried out all necessary test and examination and your puppy is healthy enough to go home.

Your puppy is right now on Transit at New Mexcio and will not be allowed to proceed with the next available flight to George Bush Intercontinental Airport because your puppy requires Health-Travel insurance. Due to the outbreak of the Corona-virus pandemic, the The government has passed a law that all pets or animals must have Health-Travel insurance to be able to move from one state to another or travel from one city to another.

Vet confirmation papers Processed {valid}

- As per ADA guidelines, it's a requirement that the vet/health confirmation certificates are issued within 10 days of travel, our veterinarians have examined and confirmed them, the certificates have been processed and validated.

Health-Travel Insurance for pet Processed {invalid}

- As per USDA guidelines, it's required that a Health-Travel Insurance Policy be provided when flying a pet at this time of the Corona-Virus outbreak.

You are required to make a refundable payment of 1500 dollars to obtain Health-Travel insurance for your puppy. This Health-Travel insurance fee shall be refunded to you 100% according to SPL Courier Service. And the

USDA Standard Pet Aviation Policy of the USA. Reimbursement will be conducted by SPL Courier Service. Refunds Agent accompanied by a delivery Agent at your Doorstep. Once we confirm payments, delivery will be resumed and your puppy be provided with the required crate and necessary arrangements will be made for delivery.

There are 2 methods for payment.

1) You can send payment online directly to our head office in Quito , Ecuador which will take a maximum of 45 minutes to pull out the insurance paper and put your puppy on board for the flight.

2) Send payment to the sender of the puppy so that he/she can make the payment in cash here at our local office. In which this might take up to 24 hours or more to pull up the insurance paper.
