The Plaintiff having moved for a Default Judgment, and it appearing to the Court that the Defendant, Eric Guerra d/b/a Lonestar Mailing Solutions, was served with a summons and a copy of the Complaint on July 29, 2019; and it further appearing to the Court that the Defendant, Eric Guerra d/b/a Lonestar Mailing Solutions, has failed to file an answer or otherwise respond in any manner to the Complaint, either before or after the expiration of the time allotted for him to do so under the Civil Rules; and the Court being otherwise sufficiently advised,

IT IS HEREBY ORDERED AND ADJUDGED as follows:

1. As to Count I, the Plaintiff is awarded a judgment in the sum of \$21,000.00, plus interest thereon at the rate of 6% per annum from February 20, 2019, until paid for all of which the Plaintiff shall have judgment;
2. As to Count II, Defendant, Eric Guerra d/b/a Lonestar Mailing Solutions is found liable for fraud in an amount to be determined by the court;
3. As to Count III, Defendant, Eric Guerra d/b/a Lonestar Mailing Solutions is found liable for lost profits and punitive damages in an amount to be determined by the court;

4. That Plaintiff be awarded judgment for its reasonable attorney fees and costs for bringing this action;

5. Execution upon this Judgment may issue forthwith; and

6. Pursuant to CR 54.02, this is a final and appealable Order and there exists no just cause for delay.
