INFORMATION OBTAINED WILL BE USED FOR THAT PURPOSE**

This firm represents Money Metals Exchange, LLC ("MMX"). It is our understanding that you recently placed a precious metals order with MMX. It was clearly explained to you, and you explicitly agreed at the time you placed your order, that you would NOT be able to cancel your order after it has been placed and prices locked. This is necessary due to the fluctuating price of the product you ordered. The non-cancellable nature of your order was explicitly reiterated on your invoice, a copy of which I have enclosed.

Because MMX simultaneously purchases replacement inventory for the items you ordered, a loss was sustained by MMX when gold prices fell before it was discovered you did not intend to fulfill your commitment to make payment. Your failure to complete your order is a breach of the terms of the contract and as a result MMX has sustained a loss of \$1,365.50.

By this letter, MMX demands that you **immediately** pay the amount as identified on the enclosed invoice. If said funds are not received within **ten (10) days** of receipt of this letter, MMX will have no choice but to seek all available remedies including commencing a lawsuit in a state court of Idaho. If litigation is necessary, MMX will also seek an award of attorney fees and costs for prosecuting this matter.

1. The amount of the debt owed by you in connection with the claim through October 9, 2022 is \$1,365.50, plus collection costs and attorney fees.
