Moomoo Trade Platform. Approximately 3 to 4 weeks ago, I asked him to contact me and left my email. Suddenly I had the so called Andrew Cartwright come to me in Instagram and say hello. He introduced himself as the Andrew Cartwright and here is the link to his Profile and Conversation w/me. <https://www.instagram.com/direct/t/340282366841710300949128261818589915952>

After Mr. Cartwright introduced me to Mr. Donald, Donald proceeded to tell me worked at FXTM-Exchange and that is was very good at placing Crypto to make 100% in 2 to 5 days or sometimes more. He asked me to send him the Bitcoin or Euthereum that I had and that he would make sure to show me a copy of the suppose Personal-Trading-Summary under my name. He did that and I have all those pictures and also the profits that supposedly were made the past 2 weeks: roughly \$1,600 to \$44,500 as of yesterday. I asked him that I need to withdraw last night, then he said: "you need to pay a fee to get all the funds released, understand!" I said I know about Securities and I had accounts in different StockTrading Companies before and do not appreciate his non-cooperation to something that is absolutely legal. I called Moomoo and spoke to: Moomoo Agent Yuling L at 9:00 am today ~01/31/23 and she told me that they are not associated with Andrew Cartwright and also Richard: Donald , the suppose Trader. He opened and account for me and told me to login with my email and a password I created: smartcorp007@gmail.com

Each 3 to 4 days that I looked the amount grew to \$44,500.  
I told him last night I had too many bills and needed to pay approximately \$25,000 in debts. Then he said "you have to pay me a fee to release your funds".  
I told him that was illegal and I need him to cooperate under the law not by Ramson.

~3: I have the Entire Conversation with suppose Andrew Cartwright on Instagram also in PDF. <https://www.andrewcartwright.com/> I am not sure weather the real Cartwright is involved or weather the person on Instagram is a imposter.

:Resolution: I need my money back and also seek damages. I do mining and I held back from purchasing equipment so that I could invest with this individual. It is likely now I am at least \$25K in damages because that was all the money I had and cannot proceed with my plans.
