While on routine patrol, I observed a black in color Volkswagen FL Tag:GWSX62 traveling eastbound on NE 10th Ave approaching N Federal Hwy. The light was solid red, at which time the vehicle failed to stop and proceeded to make the right hand turn onto N Federal Hwy failing to stop for the red light (Citation #A90SMVE). The vehicle was traveling at a high rate of speed while making the turn causing the tires to screech loudly. I then initiated a traffic stop for the violation observed at the 800 block of W Boynton Beach Blvd at which time I made contact with the driver identified via FL DL as David Steven Rosov (sole occupant of vehicle). While requesting the documents to the vehicle, I smelled and recognized the distinct odor of marijuana (based on training and experience) coming from the inside of the vehicle. Also in plain view on Rosov's lap, I observed and recognized several small pieces of a green leafy substance which based off my training and experience I knew to be suspect marijuana.


A probable cause search was conducted on Rosov's person which revealed (2) off white hard rock like substances based on my training and experience believed to be suspect crack cocaine (Net:0.3Grams) which was located inside Rosov's right front pocket. Field test using a cocaine NIK wipe tested positive for cocaine. Search of Rosov's vehicle revealed a plastic tube shaped container containing marijuana inside (net:0.6grams) which was located in the driver side door pocket. Field test using a Duquenois-Levine Reagent tested positive for marijuana. Further search of the vehicle yielded a glass pipe (bong) with marijuana residue inside that was on the passenger seat inside of a sunglasses case. All evidence was taken and submitted into BBPD Evidence.


Based on the aforementioned facts, I find probable cause to charge Rosov with Possession of Cocaine pursuant to F.S.S 893.13.6a, Possession of Marijuana (Under) pursuant to F.S.S 893.13.6b, and Possession of Drug Paraphernalia pursuant to F.S.S 893.147.1. Rosov was advised of the above charges and transported to BBPD for processing and later TOT PBCJ.

This entire incident was captured via my BWC.
