During this time, I am under the impression that I am dealing with a third party contractor of Lowes. Two weeks later we went under contract. Starting on August 1st, Andy and his crew came out to my home and for three months, they went throughout my entire home ripping everything out, but never completed anything. I have no kitchen, no flooring, and my place is trashed and my belonging are damage. After already making several payments to Andy Barnette. He has decide to run off with over \$20,000 and left my home with more than \$30,000 worth of damages. With more context, you will discover this man to be fraud and he came into my home with no intention on renovating it but to damage everything, stop working and run off with my money. The conditions of my home is not safe to live. On October 3, 2023 made a few calls and found out he does not contract through Lowes nor is he licensed.</p>
