**VIVIS - Visitor** Visa will not be necessary if the passenger will remain in the international transit area, without going thru immigration, and the passenger holds a ticket, even if issued by two or more companies.

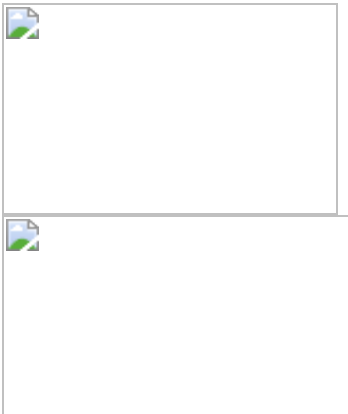

Thank you for your prompt response. I appreciate your assistance in addressing my inquiry.

I understand that you do not issue transit visas. However, I was specifically referring to the Transit Without Visa (TWOV) policy. My intention was to obtain clarification on the official policy regarding this matter, which is why I reached out to you.

The policy I provided in my previous email outlines the TWOV requirements for Vietnamese citizens transiting through Brazil, particularly via the Guarulhos International Airport (GRU). Could you please confirm if this policy aligns with the official regulations or provide me with the official website where I can find detailed information on the specific requirements for transiting without a visa for Vietnamese citizens?

Having access to the official policy is crucial for our travel planning, and it would also assist us in ensuring compliance with all necessary regulations. Additionally, I understand that airlines often advise passengers to verify visa requirements with the official consulate, but having clarity on the policy from you the relevant authority would be greatly beneficial.

For your reference, the TWOV (Transit Without Visa) requirements I included in my previous email are as follows:

Passengers with a connecting flight booked on the same ticket in transit. Exception: This TWOV facility does not apply at Curitiba (CWB), Florianopolis (FLN), Porto Alegre (POA), Porto Seguro (BPS), or Salvador (SSA).

Could you kindly confirm if these requirements are still accurate and in line with the official policy? Your confirmation would greatly assist us in our travel preparations.
